Amendment Notice

This notice is issued under section 59 of the *Environmental Protection Act* 1986 (EP Act) to amend the licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

Amendment Description

Licence L7286/1998/11 was granted on 30 March 2016 (Existing Licence) to GD Pork Pty Ltd (Licence Holder) and expires on 30 March 2017. The Licence Holder also holds Works Approval W5687/2014/1 (the Works Approval) in relation to works for an expansion of the premises to increase the production and design capacity.

The Licence Holder intends to complete works shortly and lodged a licence amendment application on 16 January 2017 to include the operation of the expanded piggery.

In granting the Existing Licence, the then Delegated Officer had regard to DER's *Guidance Statement: Licence duration* and opted to limit the duration of the licence to one year. The Delegated Officer's reasons for this were to allow other processes to be completed such as determination of appeals relating to the Works Approval, finalisation of a report on the DER odour field survey, and for the Licence Holder to substantially commence works under the Works Approval. The Delegated Officer notes that:

- The Minister for Environment determined appeals against the conditions of the Works Approval on 7 April 2016;
- DER published the report *Odour Field Assessment in the Vicinity of GD Pork, West Pinjarra* in December 2016 (Odour Report) available at www.der.wa.gov.au; and
- The Licence Holder has lodged a licence amendment application as it expects to complete expansion works shortly.

The Delegated Officer has initiated this amendment to extend the licence duration while the licence amendment application is assessed and determined.

Decision

The Existing Licence is due to expire on 30 March 2017. The Licence Holder has submitted a licence amendment application as works authorised under Works Approval W5687/2014/1 are nearing completion. The Delegated Officer has taken account of DER's *Guidance Statement: Licence duration* and extended the Existing Licence duration by 12 months.

The duration extension provides adequate time for DER to assess and determine the licence amendment application in accordance with DER's *Guidance Statement: Decision Making* and *Guidance Statement: Risk Assessments*.
