Amendment Notice

This notice is issued under section 59 of the *Environmental Protection Act* 1986 (EP Act) to amend the licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

Amendment Description

This Amendment Notice is the result of a DER initiated amendment to Licence L8101/2004/3 and relates to an administrative change to extend the licence duration. The Licence Holder details have also been amended to correct the registered business address for ACN 008 447 345.

Decision

Section 63 of the EP Act prescribes that a licence shall continue in force for such period as is specified in the licence. DER had regard to its *Guidance Statement: Licence Duration* that provides for the granting of a licence for up to 20 years duration.

The current licence is due to expire on 6 October 2016. The Licence Holder applied for a licence renewal on 8 June 2016. As part of the renewal process, DER is carrying out a full risk-based review of the premises. To allow the review to be completed, the Delegated Officer has determined to extend the licence duration by six months to allow the review process to be completed. It is expected that the review will be completed by the end of November 2016.

In determining to amend the duration of the licence, the following matters were considered:

- A risk-based review of the premises is currently being undertaken in accordance with DER's regulatory framework independent of any change to extend the licence duration;
- The premises will be subject to ongoing compliance inspections and investigations following incidents and complaints, in accordance with the EP Act:
- In the event that risk issues arise in relation to the premises, the CEO may, depending on the circumstances:
 - Amend the conditions of the licence at any time;
 - In the event of an alleged offence, exercise enforcement powers under the EP Act, including an environmental protection notice; and
 - o In the event of breach of licence conditions, revoke the licence;
- Extending the licence duration removes the regulatory burden of frequent renewals in the absence of full assessment and aids in the efficient operation of the licensing regime;
- Extending the licence duration will enable DER and the Licensee to undertake an ordered and structured implementation of DER's risk-based regulatory framework to the premises;

- Extending the licence duration will enable DER to consult with third parties
 relating to the implementation of DER's risk-based regulatory framework to the
 premises and due consideration of any submissions in assessment and
 decision-making processes.
- Third party submissions received regarding the application to renew Licence L8101/2004/3 are being considered as part of the risk-based review of the premises.
